

## Appendix 6: Israel's nukes, the Third Temple, and the Assassination of JFK

It's well known that the Deep State collaborated with the Mafia to kill JFK, but Michael Collins Piper, in his book *Final Judgment*, exposed a role played by Mossad in the assassination. Kennedy had been trying to stop the proliferation of nuclear weapons, and discovered that David Ben-Gurion was developing them at Dimona. When Kennedy insisted on inspections, Ben-Gurion resigned as Prime Minister, rather than agree to the monitoring of the Dimona plant; Piper says that he gave the green light for the killing of Kennedy by the CIA-Mafia consortium. The Mafia figures worked for Meyer Lansky, a Jewish Zionist.

JFK's successor, Lyndon Johnson, approved Israel's nukes, condoned its attack on the *U.S.S. Liberty*, and abandoned the Kennedy plan to make AIPAC register as a foreign agent. CIA liaison to Mossad, James Jesus Angleton, helped Israel obtain uranium from the U.S. behind JFK's back, and aided the Warren Commission cover-up. The U.S. has been subservient to the Lobby ever since.

Victor Ostrovsky, a former Mossad agent, revealed that **a faction within Mossad planned to assassinate President George H. Bush**, for pushing the Madrid Peace Conference of 1991 onto Israel; the assassination would be blamed on Palestinians. Another Mossad officer, Ephraim Halevy, warned Ostrovsky of the plot, and asked him to publicise it, so as to head off the plotters.

A certain right-wing clique in the Mossad regarded the situation as a life-or-death crisis and decided to take matters into their own hands, to solve the problem once and for all. (Ostrovsky & Hoy, 1990, p. 278)

Ephraim called me on Tuesday, October 1. I could sense from the tone of his voice that he was extremely stressed. "They're out to kill Bush," he said. At first, I didn't understand what he was talking about. ...

"I mean really kill, as in assassinate."

"What are you talking about? You can't be serious. They would never dare do something like that."

"Don't go naive on me now," he said. "They're going to do it during the Madrid peace talks." (p. 281)

Ostrovsky did make a public statement about it, after which one of Bush's security team contacted him and obtained the details. This foiled the plot.

In 2012, **Andrew Adler, publisher of the Atlanta Jewish Times, suggested that Mossad kill President Obama**, in order to obtain a successor who would help Israel obliterate Iran (Cook, 2012). The CIA and FBI investigated Adler, but took no action. The Mossad plot to kill Bush, and Adler's proposed Mossad hit on Obama, are in keeping with Ben-Gurion's claimed role in the assassination of JFK.

Laurent Guyénot expanded Piper's case in his book *The Unspoken Kennedy Truth*:

What was Angleton's position in the organizational chart of John Kennedy's assassination? If, as John Newman and many others believe, Angleton was the "general manager" of Oswald's handlers, and the engineer of his mock appearance in Mexico, what did he really know of Oswald's ultimate function in the plot? There is no indication that **Angleton** ever felt that he had been used by his Israeli friends, and it is therefore **more than likely** that he **was a deliberate and key participant in the conspiracy to kill Kennedy**. What has been shown beyond a reasonable doubt, at any rate, is that **Angleton, the central CIA player in the plot, was in reality more controlled by the Mossad than by the CIA itself**. (Guyénot, 2021, p. 85)

Following the release of JFK files in March 2025, Guyénot noted (2025), "the theory of Israeli guilt is reinforced by

clarifications on **James Jesus Angleton's proximity to the Mossad**. And the word is spreading on the social networks."

This indicates that, while the **CIA had wanted to conceal the link between Angleton and Israel**, the link is now so well known that the redaction of the word Israel has become ridiculously counterproductive. Similarly, on another document mentioning that Angleton "run several intelligence projects, many of them with [the Israeli Intelligence Service]", the words in brackets have also been un-redacted, as pointed out on the <https://twitter.com/wikileaks/status/1902344051766260192>> Wikileaks X account, followed by 5.8 million subscribers. ...

**The Israeli connection, first suggested by Michael Collins Piper in the 1990s, is now being raised by influential figures such as the historian Martin Sandler**, who in 2013 edited a <https://www.amazon.com/Letters-John-F-Kennedy/dp/1608192717/>> collection of Kennedy's letters, including his exchange with Ben-Gurion in June 1963. (Guyénot, 2025)

Ari Ben-Menashe was a major source used by Seymour Hersh in his book *The Samson Option*. **Ben-Menashe exposed the connection between Dimona and the Third Temple** in his book *Profits of War: The Sensational Story of the World-Wide Arms Conspiracy* (1992):

**Israel's first nuclear reactor** was set up on the Mediterranean coast in Nahal Sorek in the Yavne area. ... After the initial research yielded positive results, Minister Without Portfolio **Yisrael Galili**, a leftwing powerbroker who directed the intelligence and security services, took **upon himself with Ben-Gurion's blessing the cabinet-level supervision of the program**. After tasting success in Yavne, within six to eight months **he pushed through another nuclear plant in the Negev Desert near Dimona**, some 40 miles northeast of Beersheba.

In a memorable speech after the groundbreaking for the supersecret Dimona nuclear plant, the usually subdued **Galili stood up in a Mapai Party meeting** and, with his chest proudly pushed out, declared, **"The third temple is being built!"**

This astonished other cabinet members, who at the time did not know what he was talking about. Galili continued by saying that **the revival of Israel as a moral leader of the world was at hand and dared any of Israel's neighbors to attack**. (ben-Menashe, pp. 204-5)

"Moral leader of the world" is a reference to the Messiah laying down the law to a united world, i.e. where nation-states have been replaced by a World State.

**"Dared any of Israel's neighbors to attack" is a reference to the destruction of Al Aqsa mosque**, preliminary to building the Third Temple on the site. That shows the connection between Dimona and the Third Temple. He's saying that **Israel's nukes will stop Arab/Islamic retaliation for destroying Al Aqsa**.

During the 1973 war, when Israel appeared to be losing, Moshe Dayan said **"this is the end of the Third temple"** (Hersh, 1991, p. 223). Dayan wanted to launch a nuclear attack on Damascus and other sites (p. 225).

But **the word 'temple' was also a code-word for Israel's nukes**. Hersh says,

'The only significant objections came from within the nuclear community ... Their view was that the situation had not yet been reached for **weapons of last resort, which were then code-named, appropriately, the "Temple" weapons'** (p. 226).

And, in 1981, Hersh notes of Ariel Sharon, then Minister of Defense,

Sharon needed to control **Israel's intelligence services and its "Temple" weapons—the nuclear arsenal** (Hersh, p. 288).

If Israel were a secular state like Italy, and Zionism a mere nationalist movement like the unification of Italy, the 'temple=nukes' codeword would not make sense. But if Zionism was, all along, a religious project, and the Third Temple always a key part of it, then the code makes sense, BUT the rest of the world has been deceived with the claim that it was a mere nationalist project.

Guyénot shows that **the assassination of JFK involved both Mossad and the CIA, but that the CIA may have intended the assassination attempt to fail**. In that version of the CIA plot, Castro would be framed as the planner behind it, after which Kennedy, having survived, would attack Cuba.

Israel, aware of that CIA plot, hijacked it and had JFK killed; in a similar way, on 9/11, Mossad hijacked an Al Qaeda

plot that DID NOT involve flying planes into the towers. Freemasons played a role in the JFK assassination too:

Mason Lyndon Johnson appointed Mason Earl Warren to investigate the death of Catholic Kennedy. **Mason and member of the 33rd degree, Gerald R. Ford**, was instrumental in suppressing what little evidence of a conspiratorial nature reached the commission. **Responsible for supplying information to the commission was Mason and member of the 33rd degree, J. Edgar Hoover**. Former CIA director and **Mason Allen Dulles was responsible for most of his agency's data supplied** to the panel. (Downard and Hoffman, 1998)

Martin van Creveld, professor of military history at the Hebrew University in Jerusalem, favoured expulsion of the Palestinians, and advocated that Israel use its nukes for that agenda. David Hirst cited him in *The Gun and the Olive Branch*:

**We possess several hundred atomic warheads and rockets** and can launch them at targets in all directions, perhaps even at Rome. Most European capitals are targets for our air force. ... **Our armed forces ... are not the thirtieth strongest in the world, but rather the second or third. We have the capability to take the world down with us.** And I can assure you that that will happen before Israel goes under. (Hirst, 2003)

The **outcome of the assassination of JFK suited Israel's goals rather than the CIA's goals**. That is, LBJ made US foreign policy subservient to Israel, but **Castro was not blamed and Cuba was not attacked**. This shows that **the CIA plot was not the primary one. Rather, the CIA, Freemasons, and Meyer Lansky gangsters such as Jack Ruby, were used by Mossad** as accomplices and agents.

The centrality of the Third Temple (and hence Nukes) to Zionism explains why Israel was probably the main force behind the assassination of JFK.
